INSTITUTIONAL REGULATION OF DIGITAL ASSETS IN RUSSIA: ANALYZING TRENDS, RISKS AND PROSPECTS

The article examines the development of digital assets in Russia in the context of new legislation, including the prospects for the digital ruble. The relevance of the topic is emphasized by strategic changes in legislation, in particular, by bill No. 384598-8

«On amendments to parts one and two of the Tax Code of the Russian Federation and certain legislative acts of the Russian Federation on taxes and fees (on integration into the legislation on taxes and fees of the Russian Federation provisions on the digital ruble)», indicating Russia's desire to actively participate in global economic processes.

The article presents counter-versions on the legal status of cryptocurrencies and uncertainty in the regulation of Internet exchanges in Russia. A comparison with the UK highlights the differences in approach and ongoing uncertainty in Russia regarding the regulation of cryptocurrencies.

The result of the study emphasises the importance of developing clear rules for digital assets. The key conclusion of the article is the need to take into account both formal and informal rules of the game to ensure the effective functioning of the digital asset system in Russia. Recommendations based on global practices complement the study by providing practical guidance for improving institutional regulation in this area.
